QUESTIONS ON BIKE TYPES/ SIZES ALLOWED ON AMTRAK	
What size bikes are allowed on Amtrak	Amtrak accepts only standard size bicycles with the following dimensions/parameters: Standard bikes: Weight max - 50lbs; 70" x 41" x 8.5"; Max tire width 2"; Folding bikes: 34" x 15" x 48" (860 x 380 x 1120 mm)
	This is mainly for three reasons: 1) we know we can safely and reliably accept and handle bicycles at this weight/size wherever bicycle space is available for sale per space constraints on our equipment as well as what our bike racks can accommodate.
	2) Our reservation system only allows us to sell one type of bicycle inventory (we are currently revamping our system, which will allow us to accommodate multiple types of bicycle inventory in the near future).
	3) Every item used on or attached to the train must follow strict federal safety standards. The bike racks and tires hooks approved for use on our trains can only accommodate a maximum tire width of 2" and bikes with standard wheelbases.
Are you able to accommodate tandem bicycles on your trains?	Currently, only standard size bicycles (50 lbs. or less, 70" x 41" x 8.5") will fit in our racks. We are working on making updates that will allow us to accommodate non-standard bicycles like tandems, trikes and recumbents.
I have cargo bike that is under the 50 lb. weight limit, but is about a foot longer than a regular sized bike.  Can I take it aboard? My wife, daughter and I would like to travel from SLC Utah to Pittsburgh and return to SLC from DC. Is there a way to ensure that if we get the cargo bike on the first leg that we'll be able to get it on when transferring in Chicago, etc.?	Currently, only standard size bicycles (50 lbs. or less, 70" x 41" x 8.5") will fit in our racks. We are working on making updates that will allow us to accommodate non-standard bicycles like tandems, trikes and recumbents.
Can you accommodate a recumbent trike?	Currently, only standard size bicycles (50 lbs. or less, 70" x 41" x 8.5") will fit in our racks. We are working on making updates that will allow us to accommodate non-standard bicycles like tandems, trikes and recumbents.

Will Amtrak accept recumbents and trikes on the train? If not, why? As baby boomers age, many are switching to these for touring. Also, folks who suffer from medical issues rely on trikes for their primary form of transportation. Allowing these on trains will expand their world.	Currently, only standard size bicycles (50 lbs. or less, 70" x 41" x 8.5") will fit in our racks. We are working on making updates that will allow us to accommodate non-standard bicycles like tandems, trikes and recumbents.
For a number of years in the past I was able to travel on Amtrak trains with my tandem bicycle. Amtrak ceased accepting tandem bicycles several years ago. Why?	Currently, only standard size bicycles (50 lbs. or less, 70" x 41" x 8.5") will fit in our racks. We are working on making updates that will allow us to accommodate non-standard bicycles like tandems, trikes and recumbents.
As a recumbent bike rider exclusively, I am wondering if you would consider changing your policy about them, and allow them to be transported in the baggage car hanging on the bike rack. My short-wheel based recumbent would fit perfectly in the rack as it has the same wheelbase as a standard bike. I have been an Amtrak customer for almost 40 years, and hope to continue. Please consider changing your policy.	Currently, only standard size bicycles (50 lbs. or less, 70" x 41" x 8.5") will fit in our racks. We are working on making updates that will allow us to accommodate non-standard bicycles like tandems, trikes and recumbents. The way our bike racks are bolted into the train walls require bikes to be stored vertically. While a similar wheelbase could technically fit in some cases, the way bikes are hung next to each other may not fit wider bicycles next to a standard bicycle. In addition, we can only sell and manage one type of bicycle inventory at this time. We have plans underway to adjust bicycle rack spacing as well as to enhance our reservation system to accommodate multiple types of bicycle inventory.
Many cyclists like myself enjoy bike packing on a mountain bike or fat bike. What is the maximum tire size supported for bikes with walk on bike service?	Currently we can only accommodate bikes with a maximum tire width of 2 inches. We are working on modifications to our bike spaces and reservation system to accommodate fat tire bikes (among other types of bicycles).
Would it be possible to bring fat bikes on board in the future? I recently went skiing in Colorado via Amtrak; a fat bike would have been great to get around Winter Park.	It will be possible to bring fat bikes in the future. Right now our bike hooks, which accommodate tires 2" or less, are standard across the system. We are working on reconfiguring some spaces to accommodate not only fat bikes, but also recumbents, cargo bikes, tandems, etc.
Are electric powered bikes allowed, and if so is there a weight-limit?	Right now we don't allow electric powered bikes until we complete a safety evaluation. We'll update our policies once that study is complete.
What Type of accommodations will be available for individuals with disabilities who may ride tandems, trikes, hand bikes, and carts?	There are projects underway to modify our existing equipment and reservation system to accommodate recumbents, tandems, etc. As soon as that's available we will notify the public via press release and make the bike space available for sale on Amtrak.com.

QUESTIONS ON COST	
What does it cost to bring a bike along on Amtrak?	It depends on the route and where you're traveling; however, the fee will be \$20 or less.
If a client does not check in any baggage- could a bicycle be counted as one checked baggage in lieu of baggage as it's in the same car as it's a double charge for bike customers?	There is a fee (\$20 or less) to check a bicycle regardless of whether the passenger checks luggage or not. Bicycle rack space is limited (only 6 spots in most cases).
What is the cost? Can I travel without the bike boxed up? What about folding bikes? Any special regulations around the huge "Fat Tire" bikes that are popular now?	We no longer require you to box your bike except for between Portland and Spokane on the Empire Builder. Currently, only standard size bicycles (50 lbs. or less, 70" x 41" x 8.5") will fit in our racks. We are working on making updates that will allow us to accommodate non-standard bicycles like tandems, trikes and recumbents.

What is the fee schedule for bringing a bike? Are the bikes kept in a secure manner?	Bicycle fees are \$20 or less. Passengers are welcome to lock their bicycles on trains that offer carry-on service. Only Amtrak Crew members handle bicycles when passengers use train side checked bike service.

RESERVATIONS/ FIRST COME FIRST SERVE ISSUES	
Do I need to reserve a place?	Reservations are required on all routes except the Capitol Corridor and San Joaquins trains. Reserve your space on Amtrak.com.
Your website indicates that bike space is on a first come first serve basis. Uncertainty about the probability that there will not be room for my bike on the train prevents me from utilizing this service. At what frequency is Amtrak unable to accommodate bicycles? What does Amtrak do to ensure that adequate space for bicycles is provided?	Bike storage on most trains is reserve only except for on the Capitol Corridor and San Joaquins routes in California. To reserve space, simply click the "add bike to trip" button that appears when you search/book trains on Amtrak.com.
Hi, Suggestion: it would be nice if the mandatory reservation requirement for bringing a commuting bicycle onboard Amtrak for the Pacific Surfliner route was dropped, as is the case now (Feb 2017) for San Joaquins and Capitol Corridor lines. This bicycle reservation burden is such a hassle that I don't ride Amtrak in San Diego County. Please make it easier to ride Amtrak trains. Thanks for hearing this suggestion.	While there is currently no charge for bike storage on the Pacific Surfliner, we do require a reservation to ensure there's space available. The Pacific Surfliner carries more bikes than any other train on the Amtrak system. This is the best way to manage that demand.
Why do people need to make a reservation ahead of time in order to bring their bike onto Amtrak? BART, Coaster, CalTrain and other regional trains can easily accommodate bicyclists with no prior notice, and I think it increases ridership. Why can't Amtrak do the same?	Since space is limited, we require reservations so your bike rack space is guaranteed. Reservations also help us measure demand, analyze data, and also helps the crew know when passengers are boarding/disembarking with bicycles along their route.
If I show up at a train station with my bike and they already have four (the limit) of wheeled-on bikes in storage, will I be asked to wait for the next train?	We encourage and/or require bicycle reservations for this reason. For unreserved service on the San Joaquins or Capitol Corridor trains you may have to wait for the next train if you do not have a reservation.
Does AMTRAK have a back up plan for not having enough room if there are a lot of bikes at a station?	We require you to make a bike reservation for exactly this reason.

Will bicycle service be offered/available on the Wolverine (Chicago-Detroit)?	The state of Michigan determines whether baggage service or bikes can be carried on the Wolverine Line. Their unique equipment must undergo some modifications that meet FRA safety regulations before bike service can be offered.
Can I roll a bicycle onto the Cardinal at Maysville, Kentucky?	Unfortunately, Maysville, Kentucky is an unstaffed station and doesn't offer checked baggage service; therefore, there is no checked bicycle service on the Cardinal to/from that station.
I am thinking about traveling from <b>Detroit to San Francisco</b> with my bike. What is the cost? Does it need to be packed? Can I keep it with me as it is very expensive	Currently, there is no carry on or train side checked bicycle service on the <b>Wolverine</b> trains in Michigan.
Do you allow bikes on the <b>Lakeshore Limited</b> yet? If not, why not?	We offer Train side Checked bicycle service on the Lakeshore Limited to/from staffed stations that offer checked baggage. Visit Amtrak.com to check availability and to reserve your space.
When will your <b>Crescent</b> line have roll-on bicycle services?	The Crescent has train side checked bicycle service right now.
Will you be adding service to in between station stops on the <b>Hiawatha line</b> ? Right now the only way I can take a bike on the Hiawatha is by traveling from downtown <b>Milwaukee to downtown Chicago</b> . What options will there be in the future for riders who want bike service at the other stations on the line? Are there plans to make this more affordable for regular/monthly/10 ride ticket holders? Will there ever be bike service for the <b>Wolverine line</b> ? I know many residents in Ann Arbor and Detroit who would value the ability to take their bikes to Chicago on the train, but currently drive because there is not the availability for this at the present time. When will the train from <b>Champaign to Chicago</b> offer Roll and go?? (used that service from DC to Pittsburgh and it was fantastic!)	Projects are underway to modify equipment to expand Carry On Service to more routes (similar to the Capitol Limited route). Announcements will be made via press release and space will be available for sale on Amtrak.com once this service is expanded. Stay tuned.
I recently took my bike on the Empire Builder between La Crosse and Milwaukee. I paid \$20 each direction. I don't mind storing my bike in the baggage car, but if there was roll on service, it would be much more affordable. Is there any chance this will be available on this train in the future?	Projects are underway to modify equipment to expand Carry On Service to the Empire Builder; however the bike fee will still be \$20.
Why only 4 bikes allowed on the Missouri River Runner?	The State of Missouri determines the bicycle inventory on this route.
When I rode from <b>Milwaukee to St. Louis</b> I had to handle my bike in several ways, move it between cars at each stop, and pay a different fee per stop. Will this be standardized and made easier to understand?	The Hiawatha has a baggage car (train side checked service) and the Lincoln Service does not (Carry On Service). We can't standardize bicycle carriage across trains that use different equipment. We will take this feedback into consideration and make it easier to understand what bicycle service you are reserving. Since you were connecting between two trains and transferring in Chicago, we charged a fee and required you to reserve bike space on both trains.
What bike rack service do you have going through my town Fairfield, Iowa?	The closest station with baggage service is Mt. Pleasant, IA, ~20mi away on the California Zephyr Route.
Is there still plans to add ride on bike service to the Wolverine line that runs from Detroit to Chicago? This has been discussed for several years and still has not come to fruition. Are there plans to expand bike stowage on the <b>Vermonte</b> r line? My friends and I would like to take a trip to Vermont, but with only spots for 3 bikes and 1 train per day, it is hard to travel as a group.	The Vermonter does not operate with a baggage car and there is only space inside the train for one bike rack per passenger coach. Unfortunately 3-4 bikes is the maximum the Vermonter can accommodate.
It is hard for me to understand bike allowance on the website. The Northeast regional train from Pvd to N.Kingstown RI - may I take my bike on the train?	There is no bike service to/from Kingston, RI since it's a station that doesn't offer checked baggage. We are working on/researching a long-term solution to carry bikes on Northeast Regional trains, which will require extensive modifications to our equipment.
Is there service from <b>Norfolk, VA to NYC</b> ?	Service to Norfolk is an extension of the Northeast Regional service. The service to Norfolk does not have a baggage car/checked baggage, so no checked bike service. The Northeast Regional service shares an equipment pool with the entire Northeastern United States. In order to provide carry-on bike service, we'll need to make extensive modifications to our equipment and funding agreements will need to be made between Amtrak and several states.
When will you start roll on bike access on your Adirondack routes?	The <b>Adirondack</b> route does not have a baggage car, so will not have train side checked service. The Adirondack shares an equipment pool with the entire Northeastern United States. In order to provide carry-on bike service, we'll need to make extensive modifications to our equipment and funding will need to be allocated and agreed upon between several states.
Can I take my uncrated bike on the train from <b>Albany Oregon to Portland</b> ? How much extra do I pay?	You can take your bicycle on the Amtrak Cascades route for a \$5 bike fee each way.
Is bike service available on the Lake Shore Limited from Cleveland to Albany?	Currently, track work and elevator work are preventing us from offering bike service at <b>Albany.</b> Once finish we will restore bike service at Albany and open the space for sale on Amtrak.com.
Why is your quite-large <b>Downeaste</b> r bicycle car restricted to 5, evenly spaced bikes? When 20 or even 30 could fit with ease?	The <b>Northern New England Passenger Rail Authority</b> is responsible for determining bicycle inventory on the Downeaster.

Adding bike service to the <b>Northeast Regional trains 65/67 and 66</b> certainly checked a box to offer it on the NEC, but the overnight trains are inconvenient for trips between most station pairs. Are there any plans to expand bike service beyond the last train of the day?	NE Regional Trains 65, 66, and 67 are the only trains that travel with a baggage car; hence, why we can offer train side checked service on those trains.  Expanding bike service in the Northeast will require a significant investment to add bike racks to the entire fleet, since the entire Northeast shares a large pool of equipment. While we have plans to expand service to more trains, it will take some time to procure funding and overhaul the equipment.
Why is bike service limited on the <b>Northeaster</b> ? Shouldn't you be promoting this service rather than curtailing it?	Northeast Regional trains use Amfleet equipment which went into service in the 1970s without bicycle carriage in mind. Most Northeast Regional trains do not have baggage service so cannot offer train side checked service. The Northeast Regional service shares an equipment pool with the entire Northeastern United States. In order to provide carry-on bike service, we'll need to make extensive modifications to our equipment as well as secure funding agreements between Amtrak and several states.
What about long haul routes like <b>Empire Builder</b> ? doing a x-country bike ride like the Northern Tier of ACA many people have to do it in sections due to vacation constraints any chance roll on roll off coming to these routes?	The Empire Builder offers train side checked bike service to/from stations that offer checked baggage service as well as at Glacier Park and Winona, Minnesota.
Will Amtrak begin allowing bicycles on the <b>Downeaster</b> service this summer?	The Northern New England Passenger Rail Authority is responsible for determining bicycle availability on the Downeaster.
When will this growing intermodal type of transportation (travel with bikes) be allowed in NorthEast and other areas of Amtrak?	We are working on/researching a long-term solution to carry bikes on Northeast Regional trains, which will require extensive modifications to our equipment.
Do you ever plan to allow bikes on the <b>Downeaster</b> line? When? If no, why not?	The Northern New England Passenger Rail Authority determines bicycle available and inventory on the Downeaster line.
When will there be full bike service in <b>New York State?</b> I live in <b>Syracuse</b> and would like to be able to use Amtrak to travel with my bike without packing it in a box.	Trains in the Northeastern United States all share equipment from one large pool. In order to provide carry-on bike service, we'll need to make extensive modifications to our equipment. This will also require funding agreements between Amtrak, the State of NY and other states in the Northeast.

When will Amtrak allow wheeling on and storing bikes not in boxes to all stations on the <b>NE corridor?</b> Right now you cannot Board a train from D.C. to NYC with a bike.	You CAN board some trains from DC to NY with a bike. Check out Amtrak.com to reserve your space on the Vermonter, Palmetto, or NE Regional Trains 65,66,67 only. When bike space is available an "Add Bike To Trip" button is displayed. The NE Regional trains share equipment with all routes in the Northeastern United States (besides Acela). Adding bike service will require extensive modifications to our equipment and financial agreements between Amtrak and several states.
I live in <b>NYC</b> and as far as I can tell it's impossible to leave on an Amtrak train with a bicycle - regardless of whether it's in a box or not. Are there any plans to allow roll on service out of Penn Station? My hope is to be able to travel to Pittsburgh with a bicycle or down to Washington DC with my bicycle. Thank you.	The Vermonter offers carry on bike service from Penn Station to DC. From there you can take the Capitol Limited to Pittsburgh.  Northeast Regional trains use Amfleet equipment which went into service in the 1970s without bicycle carriage in mind. Most Northeast Regional trains do not have baggage service so cannot offer train side checked service. The Northeast Regional service shares an equipment pool with the entire Northeastern United States. In order to provide carry-on bike service, we'll need to make extensive modifications to our equipment as well as secure funding agreements between Amtrak and several states.
Why doesn't Amtrak allow bikes on all stops? In Maine, only Portland and Wells are allowed.	The Northern New England Passenger Rail Authority determines bicycle available and inventory on the Downeaster line.
When will Amtrak start providing roll aboard services between <b>Pittsburg and Philadelphia</b> ?	The state of Pennsylvania determines whether baggage service or bikes can be carried on these routes. These trains also share equipment with the entire Northeastern United states. Extensive modifications to our equipment would be required and funding agreed upon between Amtrak and several states.
I live near the <b>Trenton station.</b> There is no baggage service, yet trains with bike service stop in there. Please find a way to allow roll on, roll off service there. This has the potential to be a great market for you up and down the East Coast!	We have to take a number of things into account when determining whether to offer bike service at an unstaffed station. Mainly: 1) platform height - is it safe for passengers to lift their bicycles up to a crewmember inside the baggage car? 2) Platform length/condition - If the train requires a double stop due to a short platform, we must get permission from the host/freight railroad to do so. This also has schedule implications.
	If the above conditions are met safely and efficiently, we generally will open up the space. We have an extensive queue of unstaffed stations to evaluate at the moment. Once available we will open up for sale on Amtrak.com.

I often take the <b>Harrisburg - Philadelphia Keystone</b> service. On trains with Train side Checked service; bikes are stored inside of baggage cars where only crewmembers are allowed. On trains with 'Carry On' service, customers hang bicycles themselves inside designated areas within passenger coaches.
What security is provided for bikes brought on-board?	You are welcome to lock your bike when it is stored on board. When bikes are stored in baggage cars, only Amtrak personnel have access to that area of the train.
I cannot lift my bike, what accommodations can you provide people getting on and off the train and secure bike parking inside the train?	Customers are welcome to bring their own bike locks to secure their bicycles to the racks. Amtrak equipment was ordered over four decades ago without bikes in mind at the time. Combined with varying platform heights and lengths at stations Amtrak does not own, for now, we require customers to be able to lift their bicycles. Boxed bicycles are handled by train crews and station personnel so that is your best bet to ensure you won't have to lift your bicycle onto the train.

UNEVEN RULES: Why do you maintain a policy that is unevenly enforced stating that all bags and other items need to be removed from my bike to take it on Amtrak Cascades roll-on service? I have bags that are permanently attached and cannot easily be removed, and I've got no issue taking my bike as such on any other form of transportation. I've had major issues with baggage handlers over the years due to their adherence to this outdated policy, and I refuse to bring my bike on Amtrak until it is rectified. In the meantime, I can ride on Bolt Bus for much cheaper and bring a fully loaded touring bike on without so much as an extra fee. Until you fix this, you've lost a previous happy customer, and an entire group of touring cyclists whose travels could be made so much easier with a more lenient and consistent bike policy nationwide. I don't care about the liability of my bags. I just don't want to be harassed by every other baggage agent about my mode of transportation. Thank you.

We require this mainly for two reasons, both of which make things easier for you:

Bicycles are hung vertically by their front or back wheels using special bike tire hooks. The added weight from attached bags puts a lot of stress on your wheels as the bicycle hangs during your journey. Removing panniers and bags minimizes the risk of damage to you during boarding or your bicycle during the journey.

The boarding process moves fairly quickly (in some cases in under five minutes or less). Removing and consolidating any larger bicycle bags and accessories will make this process go a lot smoother for you and other passengers.

UNEVEN RULES; Why is bike service only allowed at certain stations? Are there any plans to expand service to all stations?

UNEVEN RULES: I have used the Amtrak Cascade, the Pacific Surfliner, the Missouri River Runner, and the Carl Sandburg without boxing my bike. It wasn't always hassling free, but I was able to do it. However, my train to/from my hometown, Albuquerque, is the SW Chief. Not having to box my bike on the SW Chief is a real game changer. Unfortunately, the places where I can embark and disembark with my touring bike on the SW Chief are very limited. With more and more people touring; especially Historic Route 66 it would be great if we could quickly and easily load and unload in more places; especially in California. The Mohave Desert can be a real show stopper for touring cyclists any time of the year. Specifically I'm wondering about the fact that there are no checked baggage stops between Flagstaff and Fullerton. Not even Williams, AZ, which is where you would ideally embark/disembark for the Grand Canyon. The same situation exists on the southern Amtrak routes. The Natchez Trace Parkway is a popular touring route, which I am going to check off my bucket list this Fall. However, there was no way to use Amtrak with my touring bike, because there are so few checked bag stops. I typically spend several thousand dollars per tour, but unfortunately Amtrak will not be getting any of it this time. In any case, thank you for not having to box or ship my bike separately more of the time. I love riding the train, but it has to be practical too.
