The more than 5,800 current league cycling instructors teach hundreds of thousands of students each year how to commute, share the road, ride in traffic, and more. More than 40 league cycling instructor certification seminars are held around the country each year.

The audit committee first reviews the form 990. When approved by the audit committee, the form 990 is sent to the entire board for their review and approval before filing with the internal review service.

04. Conflict of interest policy compliance (Part VI, line 12c)
