We do that for our members through our programs and initiatives, through our magazine, American Bicyclist, our action alerts to members about legislation in their areas, and our bi-weekly e-newsletter.

Education - The League has been the national cycling education provider for over 50 years, providing printed and electronic materials/videos to build confidence for more biking and safer streets for all. The League offers the only national certification program for bicycling educators. The League has trained more than 6,800 League Cycling Instructors, with 2,300 currently active, which have taught more than hundreds of thousands of students to commute, share the road, ride in traffic, and more. Our curriculum includes a module for drivers to improve driver safety and the safety of bicyclists. The training helps people feel more secure about getting on their bikes. More than 40 League Cycling Instructor Certification Seminars are held around the country each year.
