

Bicycling Under the Influence (BUI) laws provide specific penalties for bicyclists that are found to be riding while under the influence of drugs or alcohol. In most cases, BUI laws differ from Driving Under the Influence (DUI) laws by providing for less severe penalties and by not affecting a person's driver's license. In states without BUI laws it can be difficult to understand whether a DUI law may or may not apply to a person riding a bicycle due to the way that DUI statutes are written and how bicycles are defined. Doing a better job of recognizing and dealing with BUI can be part of a road safety agenda, but our current legal system does not seem to be equipped to deal with the issue. To be taken seriously as road users, with the same rights and responsibilities as the operators of motor vehicles, means that cyclists should avoid BUI. However, the potential harm of BUI is not readily comparable to the well documented dangers of DUI. The normalization of bicycles as a legitimate transportation mode does not mean that bicyclists should be fit into the pre-existing framework for motor vehicles, but that they should be treated with the same seriousness. BUI and DUI are separate public policy issues that deserve separate public policy responses.
