PRESIDENT-ELECT TRUMP

"We are going to fix our inner cities and rebuild our highways, bridges, tunnels, airports, schools, hospitals,"

"We're going to rebuild our infrastructure, which will become, by the way, second to none, and we will put millions of our people to work as we rebuild it."

(Has also spoken about transit and HSR)



TRUMP VISION ON TRANSPO

- ~\$140 billion in tax incentives to private sector to do P3s
- > Transform crumbling infrastructure-
 - "Cost-effective" roads, bridges, tunnels etc.
 - "Cut wasteful spending in boondoggles"
- Create construction and manufacturing jobs
- > Streamline permitting and approvals
- ➤ Maximize Flexibility to states
- ➤ Incorporate new technologies & innovations (next gen cars)

> \$ 1 Trillion for:

- > Airports
- > Energy infrastructure (pipelines, etc)
- Roads, bridges and tunnels





- > 2009, 2011, 2012, 2013, (2014) in Senate
 - Dems controlled Senate
 - ➢ 60 vote threshold
- >2015 in House (transit funding)
 - > Failed 212-214







EXAMPLE- BALLOT MEASURES

Los Angeles County, CA - Measure M

> includes \$3.9 billion in investments for bike infrastructure.

Santa Clara Valley, CA - Measure B

> \$250 million is allocated to bike infrastructure.

Atlanta, GA - Transportation Special Purpose Sales and Use Tax

> \$213 million for bicycle and pedestrian projects, comp. streets, etc.

Grand Haven, MI - Bicycle Path Millage Proposition -

➤ 6 million total \$300,000 annually.

Rhode Island - Question 6

> \$10 million to expand the state's bikeway network.

P3S AND BIKE /PED

Massive need, but the devil's in the details

➤ long-term contracts and how the project can be used,

P3 legislation varies state by state

- > 33 states have enabling legislation for P3s in transportation.
- ➤ NCSL has also produced a <u>toolkit</u> with guidance
