

FEEDBACK TO IMPROVE:

To maintain and improve on La Porte's Bronze-level Bicycle Friendly Community award, BFC Reviewers recommend...

- » Ensure that your Complete Streets policy is followed for all projects, and that compliance is tracked. Ensuring compliance with a Complete Streets policy is an important and often low-cost way to add to your bicycle network. Striping bicycle lanes as part of repaving operations can save 40% of the cost of adding a bicycle lane. If necessary, revisit your Complete Streets policy and process to ensure better compliance.
- » Continue to improve and expand the low-stress bike network for all ages and abilities, and ensure that your community follows a bicycle facility selection criteria that increases separation and protection of bicyclists based on levels of motor vehicle speed and volume.
- Develop a design manual for bike facilities that meets current national standards or adopt the FHWA's Small Town and Rural Multimodal Network Guide. This will make it easier for City staff to propose and implement bicycle facility designs that have been shown to improve conditions for people who bike in other similar communities throughout the United States.
- » Revisit the City's zoning laws to enable mixed-use zoning to enable more bicycle-friendly developments and put your residents in closer walking and biking distance to their daily destinations.
- Develop community-wide Bicycle Parking Standards to ensure that APBP-compliant bicycle parking is available in areas near transit and urban activity centers. Without secure and convenient bicycle parking it is difficult for a person to choose to ride their bicycle for transportation or utilitarian trips.
- » Increase bike safety education and learn-to-ride educational opportunities for youth, including in-school bike education. Work with local bicycle groups and interested parents to create Safe Routes to School programming and on-bike learning opportunities at all K-12 schools. Providing bicycles in schools for on-bike education is strongly encouraged to ensure that all students can learn to safely ride a bicycle regardless of the availability of a bicycle in their household.
- » Increase the number of local League Cycling Instructors (LCIs) in your community, either by hosting an LCI seminar or sponsoring a City staffer or local bike advocate to attend an existing seminar elsewhere. Having several active instructors in the area will enable you to expand cycling education for youth and adults, recruit more knowledgeable cycling ambassadors, deliver Bicycle Friendly Driver education to motorists, and have experts available to assist in encouragement programs. - Expand bicycle education opportunities for adults. Partner with existing organizations like the library, YMCA, and community groups that may willing to teach, host, or lead classes, workshops, or other educational sessions.
- » Work with local League Cycling Instructors (LCIs) and local employers to offer Bicycle Friendly Driver training to motorists in La Porte, particularly to professional drivers and fleet operators. Learn more at https://bikeleague.org/bicyclefriendlydriver.

FEEDBACK TO IMPROVE, CONTINUED:

- » Develop encouragement outreach methods and programs that specifically target families, women, seniors, low-income, and people with disabilities, in addition to general non-targeted outreach and media campaigns that discuss current and new bicycle facilities, safe driver and bicyclist behavior, and events related to walking and biking.
- Your application indicated that your community is currently updating a bicycle master plan. This is a great step to improving conditions for bicycling and institutionalizing processes for continual improvement. Your Bicycle Master Plan update should take advantage of best practices that are applicable to a community of your size, including the use of separated and protected bike lanes, targeted education programming, and demonstration projects to help the community understand possible bicycle facilities. Ensure that the new Plan includes specific and measurable goals, a strong implementation plan, and dedicated funding or an annual budget to ensure its success.
- » Involve the City's council people and budgeting system into bicycling improvement efforts in La Porte. Make sure that elected officials and decision makers are able to see and experience the benefits of building out your bike network, such as by hosting frequent community bike rides in which the Mayor and councilmembers are highly encouraged to participate.
