KEY STEPS TO SILVER



- Keep expanding low-stress bicycling network through good design, context appropriate bike facilities and speed reduction.
- Develop a design manual for bike facilities that meets current national standards or adopt the FHWA's Small Town and Rural Multimodal Network Guide. This will make it easier for town staff to propose and implement bicycle facility designs that have been shown to improve conditions for people who bike in other similar communities.
- >> Work with local businesses and building owners to increase the amount of high quality, APBP-compliant, bicycle parking throughout the community. Ensure that people arriving by bicycle have a secure and legal place to lock their bikes at popular destinations.
- >> Work with law enforcement, businesses, public agencies, and other institutional partners to develop a distracted driving campaign that includes public messages; institution-specific messages, training, or policies; and high visibility enforcement.
- Your application indicated that your community is currently creating

- a bicycle master plan. This is a great step to improving conditions for bicycling and institutionalizing processes for continual improvement. Your bike plan should build upon other completed plans for your downtown, park system, and infill development to create a safe, comfortable, and connected bicycle network.
- Ensure that your community follows a bicycle facility selection criteria that increases separation and protection of bicyclists based on levels of motor vehicle speed and volume, and that your bike plan reflects this approach to safety through better bicycle facilities.
-) Improve bicycle safety education for students of all ages by incorporating on-bicycle education. Providing bicycles in schools ensures that all students can learn to safely ride a bicycle regardless of the availability of a bicycle in their household. Work with local bicycle groups and interested parents to expand and improve the Safe Routes to School program, including expanding bicycle education to high schools.
