» Ensure that your 2019 Complete Streets policy is followed for all projects, and begin to build out an on-road bikeway network. Keep implementing the 2017 Bicycle and Pedestrian Master Plan to build the Lake Trail and make it easier for people in Culver to connect to the trail from their homes and workplaces by bike. Ensure that your community follows a bicycle facility selection criteria that increases separation and protection of bicyclists based on levels of motor vehicle speed and volume.

» Adopt a bike parking ordinance for new and existing buildings that specifies the amount and location of secure, convenient bike parking available. Develop community-wide Bicycle Parking Standards that adhere to current APBP guidelines. (See https://www.apbp.org/bicycle-parking-solutions)

» Bicycle safety education should be a routine part of education for students of all ages, and schools and the surrounding neighborhoods should be particularly safe and convenient for biking and walking. Work with local bicycle groups and interested parents to create Safe Routes to School programming for all K-12 schools.

» Develop bicycle education opportunities for adults, including seasonal residents, tourists, bicyclists, and drivers.

» Improve Bike Month activities by creating a Bike to Work Day event, community-wide bicycling celebration event, commuter challenge, and/or a Mayor's Ride.

» Provide education to all law enforcement officers on bicycle safety, bicycling skills, and traffic laws as they apply to bicyclists and motorists. Develop a bike patrol unit within the department.

» Create an official Bicycle & Pedestrian Advisory Committee (BPAC) to create a systematic method for ongoing citizen input into the development of important policies, plans, and projects. Ensure that the members of the committee reflect the diversity and ability levels of cyclists in your community.
