FEEDBACK

- NYS DOT should officially endorse the NACTO Urban Bikeway Design Guide, incorporate its designs into state engineering and design manuals, and encourage its use on the state highway network in urban areas, including collector and arterial roadways.
- Adopt a safe passing law with a minimum distance of 3 feet to address bicyclist safety.
- Dedicate additional resources towards fully implementing the state's existing bicycle plan.
- Adopt a statewide bicycle plan that addresses each of the five "Es", has clear implementation actions, and performance measures to gauge success. The state's last bicycle plan was adopted more than a decade ago.
- Adopt performance measures, such as mode shift or a low percentage of exempted projects, to better track and support Complete Streets Policy compliance.
- Dedicate state funding for bicycle projects and programs, especially those focused on safety and eliminating gaps and increasing access for bicycle networks.
- New York has a high number of bicyclist fatalities. Ensure that bicycle safety is a major emphasis in all transportation projects, programs and policies to address this issue.
- Develop a Police Officer Standards and Training (POST) curriculum for bicycling enforcement both for new officers and continuing education - focus on laws related to bicyclists, interactions between motorists and bicyclists, and bicycle collision investigation.
- Establish a statewide bicycle advisory committee to provide accountability for bicycle projects and programs.
