Summary

Florida has made significant progress in recent years to update and upgrade its efforts within the state Department of Transportation related to bicycling. These efforts come after years of being the most dangerous state to bike and walk in the United States. Florida remains one of the more dangerous states for bicyclists, with a per capita bicyclist fatality rate more than one standard deviation above any other state. However, this fatality rate does not account for recreational bicycling in the state and the per bicycle commuter rate points to potential improvement.

One way in which Florida has been innovative in addressing its historic bicycle and pedestrian safety issues is the TransPed Initiative. This data and geographic-driven tool provides a one-stopshop for pedestrian and bicycle data, bringing together over 70 data layers. As this tool is deployed planners, engineers, and others will gain access to a powerful data analysis and visualization tool that can support efforts to improve biking and walking.

One area where Florida still has a lot of progress to make is stronger laws related to driving, particularly distracted driving. The state's lawmakers have not enacted laws that have been widely adopted by other states that would allow more proactive enforcement, such as a primary enforcement texting ban.

Feedback Points

Repeal the state's mandatory bike lane law. These types of laws ignore the quality and safety of available bike lanes. The best way to get people to use bike lanes is to make them safe, convenient, and connected so that they are appealing and accessible to people who bike.

Florida has a long and sustained record as one of the most dangerous states for bicyclists. Florida has the highest per capita bicyclist fatality rate by two standard deviations and this rate is increasing. This extraordinary safety crisis deserves extraordinary actions by FDOT and all communities in Florida to improve traffic safety, particularly for people who bike and walk. Florida should develop and adopt a statewide bike plan. While Florida has taken steps to institutionalize the state's complete streets law and create better bicycle facilities the state still does not have a statewide bike plan to provide a consistent and comprehensive framework for long-term improvements.

Florida is a large and diverse state that needs similarly diverse educational materials so that drivers, pedestrians, and bicyclists are informed about traffic laws and using the road safely. Public education efforts, and driver education, should attempt to bridge cultural gaps relevant to recent migrants and older person in order to effectively reach these groups with information about safe riding and safely sharing the road with bicyclists.

The Florida legislature is considering a bill that would include vulnerable road users in the state's current Move Over law. This would be a great step towards expanding protections for people who bike and walk.

Adopt a primary enforcement texting ban for all drivers that prohibits, at a minimum, writing or sending text messages while driving. As of July 217, 43 states have a primary enforcement texting ban for all drivers.

The Florida legislature should improve existing Vulnerable Road User legislation so that is enforceable regardless of whether a driver leaves the scene of the crash.
