2018 Progress Report

Hawaii has mixed signals from its federal data, but one thing jumps out.

According to data from the Federal Highway Administration, Hawaii has struggled to use federal funds on bicycling and walking projects, including three years where it spent a negative amount. This is surprising because Hawaii has a law, HRS 246-18, that requires the Department of Transportation to report annually on bikeway projects and expenditures, including spending at least two percent of federal funds on bikeway projects.

Featured Statewide Members - Hawaii Bicycling League and PATH



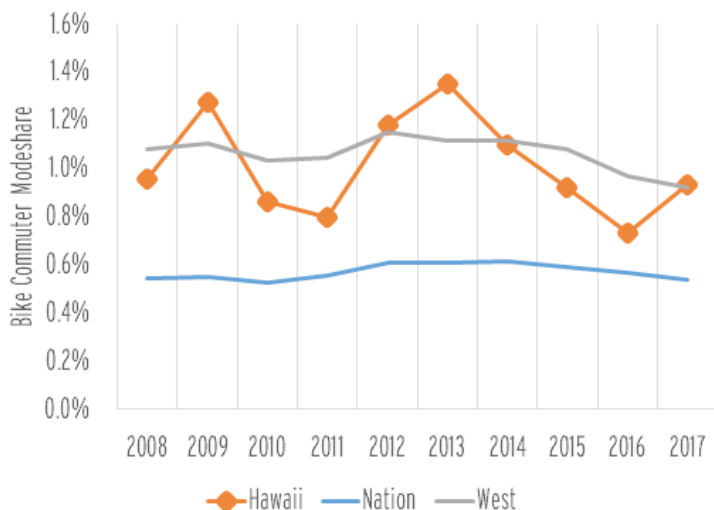
Hawaii Bicycling League (HBL) is a 501(c)3 non-profit organization founded in 1975. Our Mission is to enable more people to ride bicycles for health, recreation, and transportation through advocacy, education, and events. Each year we host several large events, like the Honolulu Century Ride and Haleiwa Metric Century. We advocate for positive changes that will help make Hawaii a cycling paradise and encourage more people to ride bicycles.



PATH is a community-based, grassroots 501(c)(3) non-profit public access advocacy organization serving Hawaii County. Our mission is to safely connect people and places on Hawaii Island with pathways and bikeways. PATH was founded in 1986 in response to a growing need for places to walk, bike and hike safely and legally in Hawaii County.

Other organizations such as Maui Bicycling League and Kauai PATH add to a strong advocacy community in Hawaii.

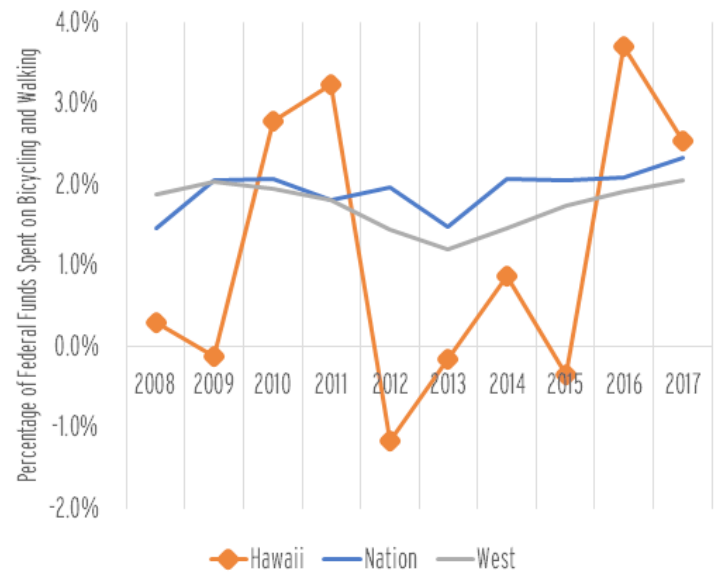
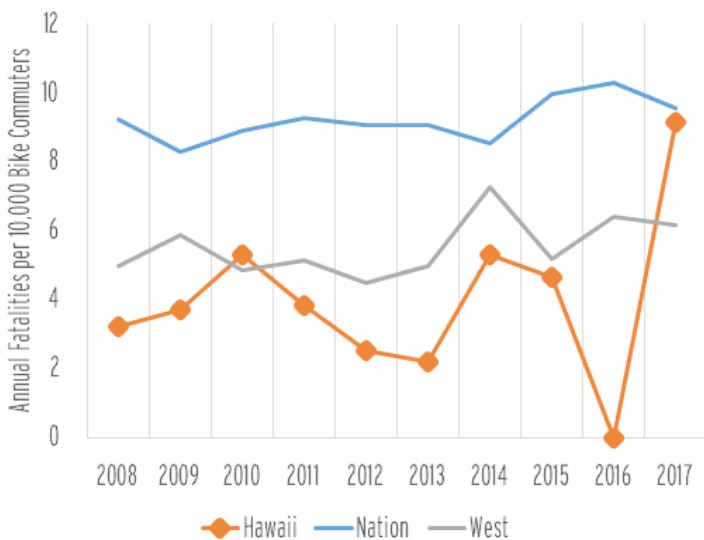

Featured Agency - Hawaii Department of Transportation & Public Facilities (Agency did not respond)

The Hawaii Department of Transportation and Public Facilities last adopted a statewide bike plan in 2003, meaning it falls outside of the League of American Bicyclists' recommendation to adopt a statewide bike plan at least once every decade and is not counted as meeting our Bicycle Friendly Action criteria.

In that last bike plan, the stated goal was "To establish bicycling as a safe and convenient mode of transportation for residents and visitors throughout the state." That stated goal was to be pursued using a "5 E" approach of focusing on Engineering and Planning, Education, Enforcement, Economics, and Encouragement. Each "E" included several recommendations, but the bike plan noted that "The recommended actions are neither mandates nor firm commitments."
