Successes & Suggestions

The Bicycle Friendly State report card is based on over 100 data points for each state and input from state agencies and advocates. Based on the information we obtained for Arkansas, the League of American Bicyclists believes the following actions will improve the safety, comfort, and accessibility of bicycling in Arkansas.

The Arkansas DOT has two exciting initiatives related to bicycle tourism:

1) developing the state's first U.S. Bicycle Route, and 2) developing Hub communities that promote bicycle tourism. These initiatives can be used to catalyze bicycle facility development and bicycle culture.

Congratulations on passing Act 650, which makes Arkansas the second state to adopt the full "Idaho Stop." Under this law, people biking in Arkansas can treat stop signs as yield signs and proceed through red lights when no other traffic is nearby. This law has been successful in Idaho for over 30 years and should make bicycling easier in the state of Arkansas.

The Arkansas DOT has initiated an update of its 2005 Bicycle Accommodation Policy and 2005 Sidewalk Policy. This is a great opportunity for the Arkansas DOT to learn from best practices developed over the last decade and for people who bike and walk in Arkansas to tell the DOT that they need better infrastructure.

Adopt a law allowing transportation agencies to post 20 mph or lower speed limits under certain circumstances.

Arkansas has set a safety target [https://safety.fhwa.dot.gov/hsip/spm/state_safety_targets/] that anticipates an increase in the number of non-motorized fatalities and serious injuries. While this target may reflect current trends, it is also a statement of goals and Arkansas should set goals that reflect a commitment to improving road safety and reaching zero deaths and serious injuries.

Adopt a statewide Complete Streets policy. The National Complete Streets Coalition has a model state policy and a variety of other resources to ensure adoption and implementation.

FHWA's Bicycle Count Pilot Program found that continuous bicycle counters can save staff time and provide more robust data than manual counts. Arkansas should consider starting a continuous counter program. Find more resources here: http://www.pedbikeinfo.org/topics/countingestimating.cfm

Install a Protected Bike Lane on a state-owned road.

Adopt the NACTO Urban Bikeway Design Guide in order to ensure that guidance on a wide variety of bicycle facilities is available to all staff within your state DOT.
