FEEDBACK

The Lousiana Department of Transportation and Development last adopted a statewide bike plan in 2009. There currently appear to be no efforts to update or create a new statewide bike plan that would reflect changes in best practices over the last 15 years. The state's bicycle suitability map was last updated in 2012 and the state's bicycle planning tool was last updated in 2019. Lousiana should create a new statewide bike plan, or active transportation plan, that reinvorgates its planning and implementation efforts for the safety of people who bike. The majority of bicyclists killed in Louisiana are killed on state-owned roadways, in both urban and rural areas.

Louisiana does not provide laws establishing default urban area speed limits. Providing clear legal authority or guidance for how communities may establish 20 mile per hour speed limits on streets in urban or residential areas would benefit the safety of all people using Louisiana's streets.

Spend at least 2% of federal transportation funds on biking and walking improvements. Since 2010, Lousiana has only met this key Bicycle Friendlly Action in two nonconsecutive years.

Louisiana has a bicyclist fatality rate worse than the national average. High-speed arterial roadways, often owned by the state DOT, are the most common place people biking are killed. Improve those roadways to improve bicycle safety.

The Louisiana Department of Transportation and Development has formed a Complete Streets Advisory Council to work with the Department to adopt and maintain an up-to-date Complete Streets Policy.

TOP TIP
