FEEDBACK

Adopt a statewide Complete Streets policy or other policy that institutionalizes planning, designing, and building safe places for people to bike and walk as part of the transportation system. Oklahoma is one of only 14 states without a resolution, policy, or law that addresses creating a transportation system for all of the ways that people move. This type of policy may also address issues such as street trees, median trees, or how land use and zoning impacts state investments.

Oklahoma is in the home stretch of adopting its first-ever statewide bike plan. Congratulations on this effort and the League of American Bicyclists looks forward to its final adoption and future efforts informed by its approach.

Oklahoma does not provide laws establishing default urban area speed limits. Providing clear legal authority or guidance for how communities may establish 20 mile per hour speed limits on streets in urban or residential areas would benefit the safety of all people using Oklahoma's streets.

Spend at least 2% of federal transportation funds on biking and walking improvements. OKDOT recently announced \$36 million in Transportation Alternatives funding for 43 projects throughout the state. Ensuring that those investments are accurately counted by Federal Highway Administration may allow Oklahoma to meet this key Bicycle Friendly Action metric.

Provide state backing for land use and zoning controls that improve walkability, such as following Minnesota's model for reforming parking minimums.
