FEEDBACK

Rhode Island sets default urban area speed limits above 20 miles per hour and does not provide clear legal authority or guidance for how communities may establish 20 mile per hour speed limits on streets in urban or residential areas. We know that slow road save lives and clearer laws and guidance supporting slower streets will benefit the safety of all people using Rhode Island's streets.

Spend at least 2% of federal transportation funds on biking and walking improvements. Rhode Island has not met this key Bicycle Friendly Action metric for any single year since 2018. Over the last 5 years, 17% of traffic fatalities in Rhode Island have been people biking or walking, and funding should reflect the need to invest in their safety.

The "Rhode to Bicycle Safety" education program covers all facets of bicycle safety and is offered to 4th and 5th grade elementary school students. The program also features on-bike instruction for all students no matter their ability level with trained instructors. This is an exciting program deserving continued support.

ONE SUCCESS

The Rhode to Bicycle Safety teaches elementary school-age children valuable skills for safe bike riding. Under the program, RIDOT provides the instructors, bikes and helmets, and all other equipment at no cost to participating schools. This is a great program that gets youth Ready to Ride!

TOP TIP

Roundabouts are a featured Safety and Engineering practice by the Rhode Island DOT and it would be great to see a broader focus on speed management by the Rhode Island DOT.
